

## PROCEEDINGS OF THE STURGIS CITY COUNCIL

The Common Council of the City of Sturgis met in special session starting at 6:30 p.m. on Thursday, July 23, 2015 at the Community Center-Meade Room. Present: Mayor Mark Carstensen, Alderpersons Jason Anderson (arrived at 6:35, left at 7:11), Mike Bachand, Branden Bestgen, Rod Bradley, Tony Dargatz, David Hersrud, Adam Martin, and Ronald Waterland. Also present: City Manager Daniel Ainslie and City Attorney Greg Barnier. Absent: none.

Mayor Mark Carstensen led everyone in the Pledge of Allegiance.

Motion by Waterland, second by Martin to approve the agenda. This motion was rescinded.

Motion by Bestgen second by Martin and carried with all members presents voting yes to approve the agenda with the addition of #6 – Executive Session.

Motion by Waterland, second by Hersrud and carried with Bestgen, Carstensen, Hersrud, Martin and Waterland voting yes, Anderson and Bradley abstaining, and Bachand and Dargatz voting no to approve a special events license for the Oasis Bar at the Harley-Davidson Rally Point for Rally events on July 31<sup>st</sup> thru August 8<sup>th</sup>.

Motion by Hersrud, second by Anderson and carried with Anderson, Bachand, Bestgen, Carstensen, Hersrud and Waterland voting yes, Bradley abstaining and Dargatz and Martin voting no to approve a special events license for One Eyed Jack's Saloon at the City Park for Supermoto Race, and motorcycle shows and events on July 30 thru August 8<sup>th</sup>.

Motion by Hersrud, second by Anderson and carried with Anderson, Bachand, Bestgen, Carstensen, Dargatz, Hersrud, Martin and Waterland voting yes and Bradley abstaining to approve a special events license for One Eyed Jack's Saloon at the Sturgis Fairground on August 6, 2015 for a non-traditional dirt track race.

Motion by Martin, second by Bestgen and carried with all members present voting yes to go into executive session for personnel and contracts at 7:06 pm.

Motion by Bestgen, second by Waterland and carried with all members present voting yes to return to regular session at 7:49 pm.

Motion by Bestgen, seconded by Martin and carried with all members present voting yes to adjourn the meeting at 7:49 pm.
