Background/History

Request for a change in zoning from Low-Density Residential (undeveloped) to PUD to allow for a new Senior Living Complex located at the corner of Moose Drive, Dolan Creek Road and Ferguson Drive (see map). The Senior Living complex will consist of market rate apartments, townhomes and common space. Current City Ordinance would not allow a mixed use in the current low-density zone. This project will eventually be part of TIF #14 which will include several sidewalk, curb & gutter and storm drain improvements in and around the complex. TIF #14 will require the additional approval of a formal Project Plan.

Neighboring landowner concerns:

On September 22, 2016, 16 notifications were sent to landowners within 150' of the applicant's property with the following results:

Approve = 66% (5)

Disapprove = 6% (2) Note: Mr. Anderson who lives on Ferguson was present at the Planning meeting and stated he wanted more information and chose to attend the meeting. The other resident returning a disapproval stated she needed more time to think about it.

No Response = 28% (9) approval implied

City staff supports this request.







Commissioners expressed the desire to have more regulations in place regarding in-home business in order to be fair and consistent with all applicants. Commissioner Norstegaard made a motion to recommend approval with a 1-year review. 2nd by Gerberding. Vote = Yes by Norstegaard, Gerberding and Hughes. No = Monahan (this type of business belongs in a commercial area) and Olson (opposed to gun sales in general, especially in residential areas). (Treloar abstained). The motion to recommend approval passed 3-2, 1 abstained.
